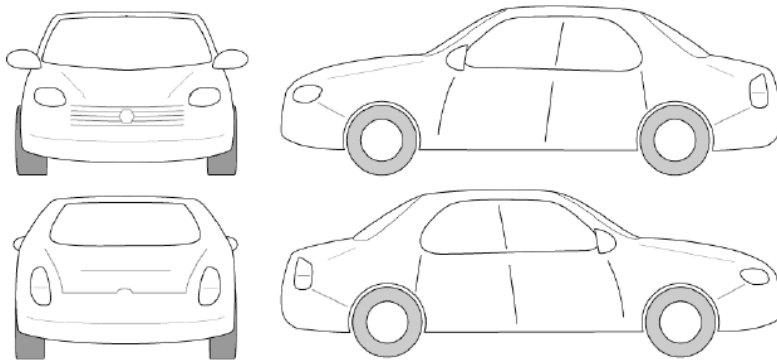

4.5 The renter has to takes the photo of any damage as evidence.

4.6 The renter must take the photos (or make the copies) of his/her driving license and personal identification card or passport.

4.7 The Renter must present the personal identification card or passport, driving license and credit card (used for making the payment(s) on the website). Otherwise, the rent will not be done.

4.8 The Owner must take a photo with the Renter.

5. The Renter guaranteed that while using the car, the Renter will not smoke and drink in the car. The Renter will also keep clean the car and all of its tools. After time of returning the car to the Owner, the car must be returned in the original condition without any damage. If any damage occurs, then the Renter will be responsible for it.

6. In the case that the Renter wants to renew the contract, the contract can be renewed by calling CALL CENTER number 061-995-5656 two days before the date of returning the car in order to postpone the date with extra charge of contract renewal at THB 250. Otherwise, the Renter will be fined for THB 5,000 per day. This amount will not be included in any rental. If the Renter has returned the car after the date and time of returning the car, the Renter will be sued.

7. The Renter promised not to rent out the car to any other individual, unless the Renter receives a written consent from the Owner.
8. If the Renter violates any agreement or rental regulation of this contract or damage the car, then the Renter will allow the Owner to take the deposit in 3. And the Renter must also compensate for any additional damage without any exemption. The action of taking the deposit will not affect the legal right of the Owner to claim for any damage or fine.
9. The Renter agreed to make any unpaid payment within seven (7) working days after the Renter does not make the payment. Otherwise, the Renter will allow the Owner to immediately take any legal proceeding. The Renter agreed to pay for the interest at the rate of 15 (Fifteen) percent per year to the Owner after the violation until the payment is made.
10. The Renter guaranteed that if the car is damaged during the rental period, then the Renter will agree to be fined as follows.
 - 10.1 In the case of any accident not caused by the Renter and any claim document is obtained from any insurance company, the Renter will not be fined.
 - 10.2 In the case of any accident caused by the Renter and any claim document is obtained from any insurance company, the Renter must pay for THB 3,000 – 50,000. The payment amount will be dependent on the damage and repair period if the car is heavily or completely damaged.
 - 10.3 In the case of any accident without any other party and there is no claim document from any insurance company, the Rental must fully pay for the damage without any exemption.
 - 10.4 If the Renter does not return the rental property to the Owner within the period of returning the car because of any loss, fire or violation to the rental property in the form of steal, embezzlement, corruption or crime relating to any other property that the Renter involves or does not involves in it; the Renter must be responsible for it and compensate for the damage according to the value of the car by referring the selling price of the car at that time.
11. The Renter must be responsible for any damage caused by returning the rental property in the condition different from the condition stated in 4. The Renter will agree to accept the mentioned damage and any other damage caused by the loss of any benefit since the Owner cannot rent out the mentioned property to any other individual.
12. The Owner fully refueled the car's fuel tank before the rental period. The Renter also agreed to refueled the fuel tank again and provide any receipt. If the fuel tank is not full, then the Renter will allow the Owner to deduct the deposit.
13. The Renter promised not to drive the car outside the stated route. Otherwise, it will be considered that the Renter is suspicious and this rental contract will be automatically terminated. With the contract termination, the car must be immediately returned to the closest police station at that time.

14. The Renter promised not to drive to or close to Thailand’s frontier in order to prevent not being suspicious. Otherwise, the Owner will have the right to sue and allow any police officer to immediately take the car.

15. After any damage and fine, the Renter will be fined for 15,000 baht per day after the due date if the Renter does not pay for the rental or any debt under this contract.

16. For the contract termination, the Owner has the rights to terminate the contract and to ask the Renter to return the rental property to the Owner in the following cases.

16.1 The Renter does not pay for any due debt under this contract regardless of any notification.

16.2 The Renter does not comply with any agreement of this rental contract and keep violating the agreement after being notified by the Owner.

16.3 If the Renter is sued is any criminal or civil case that is reasonable for the Owner to believe that the mentioned case may affect the Renter’s compliance with this contract.

16.4 The Owner has the rights to immediately terminate this contract and to re-take the rental property, if the Owner uses the right to inspect the rental property and considers that the rental property may be damaged because the Renter continues using the rental property.

17. For a right of the Owner, the Renter allows the Owner, Owner’s representative(s) or any individual authorized by the Owner to inspect the rental property and ensures the compliance with the contract at any time during the rental period. If the Owner has any reason to believe that the Renter may use the rental property for any purpose going against any stated rental purpose or any reason to believe that the rental property may be damaged.

18. I, the Rental, and Owner thoroughly acknowledged the statements in this contract and agreed to comply with the contract without any objection. The names were signed as evidence.

19. Two copies of this contract are made with consistent statements. Both parties thoroughly read and understood the statements, and then signed their names in the presence of the witnesses. Each copy is held by each party.
